(Monday 28 November 2011).

Items of general business will be posted to the website www.qfa.net.au by Tuesday 29 November 2011. Written requests for postal votes must be received by the Secretary no later than Monday 28 November 2011. Postal votes must be lodged in writing with the Secretary no later than 24 hours prior to the AGM.

Elections for 2012

Under the provisions of the Rules of Association of the Queensland Federation of Astrologers Inc notice is hereby given that Nominations are called for the election of Officers and Committee of the QFA Inc for 2012. Section 20, sub-section(a), - "The Secretary shall at least 28 days before the Annual General Meeting call for nominations for such elections by such means as the committee may consider practical in all the circumstances so as to inform members entitled to attend the Annual General Meeting and vote of the fact that nominations are open."

The Committee positions are President, Vice President, Secretary, Treasurer plus 4 Committee members. Nominations of eligible persons must be given to the Secretary in writing with the name and signature of the person being nominated, together with the name and signature of the person nominating them. Members MAY nominate themselves. This must be received by the Secretary no later than 14 days before the Annual General Meeting. Nominations received after the 28th November 2011 will not be accepted. Members may be nominated for more than one position and if they are elected to a position their nomination for further positions is automatically rescinded.

A Nomination form is attached and may be photocopied if more are needed. Forms will also be available at the monthly meetings in October and November and on the website www.qfa.net.au.

Nominations for the QFA Inc Committee will be posted to the web site by Tuesday 29 November 2011.

Postal vote applications must be received by the Secretary in writing, no later than 28 November 2011.

Postal votes must be lodged with the secretary no later than 24 hours prior to the AGM.
